3. The five corollas of plum blossoms indicate five major continents on which Chinesebusinesswomen are spread. Those plum blossoms surrounding the globe symbolize the Chinese businesswomen located in Taiwan envisioning the world and generating consensus from a macroscopic aspect.
4. The latitude and longitude lines on the globe stand for worldwide network information delivery and exchange of business opportunities.
5. Not only does the full view of the emblem express our federation's worldwide scope and embracing of trend but it also represents the bright and promising vision of the worldwide Chinese women.

緣起與沿革

本會創立於 1994 年，組織分佈於世界三大洋六大洲，會員皆為華人工商婦女菁英。成立迄今共有 65 個分協會，其緣起與組織歷史沿革如下：

- 1994 年 6 月 19 日，本會創會理事長周文璣女士（前明星花露水董事長）於美國舊金山創立「世界中華工商婦女企管協會」，期盼結合全球工商婦女之智慧，強化國際資訊交流，促進工商經濟發展，並協助政府推動國民外交。
- 1996 年 10 月 2 日柯杜瑞琴女士接任世界中華工商婦女企管協會第二屆理事長。
- 1997 年 11 月 19 日更名為「世界華人工商婦女企管協會」，向內政部申請報備登記通過，成為唯一由台灣發展至全球之國際工商婦女社團組織，並以「心懷世界、掌握脈動、建立網絡、發展經貿」為本會宗旨。
- 1998 年 4 月柯杜瑞琴女士榮任更名後首任理事長（第三屆），並敦聘李登輝總統夫人曾文惠女士為榮譽理事長，創會理事長周文璣女士為永久榮譽理事長。
- 1998 年 11 月，本會名稱與會徽正式通過經濟部中央標準局註冊及專用權。同年並在美國華盛頓註冊，正式規範會員體使用本會名稱與會徽的權利與義務。
- 1999 年休士頓市長李·布朗頒訂每年 5 月 1 日為「世界華人工商婦女企管協會日」之榮譽證書予本會。
- 2000 年 10 月 20 日，柯杜瑞琴女士創立「中華民國華商婦女企管協會」，並加入本會為團體會員。
- 2001 年 2 月本會組織發展遍佈全球三大洋六大洲，遂向內政部正式登記為國際社團。柯杜瑞琴女士連任「世界華人工商婦女企管協會」第四屆理事長，並敦聘辜嚴倬雲女士為榮譽顧問。
- 2001 年 10 月柯杜瑞琴理事長創辦『華冠獎』選拔頒獎活動，每三年遴選十位世界十大傑出華商婦女華冠獎得主。
- 2003 年南非內政部長布德萊齊訪華，本會安排布德萊齊部長經貿演說，透過交流增進兩國友邦情誼，促成核准國人赴南非落地免簽證之福祉。
- 2004 年 10 月林廖玉女士接任第五屆理事長，為符合國際性社團的性質，同年將本會『理事長』職稱更名為『總會長』。
- 2007 年 9 月黃淑慧副總會長輔導成立本會第 36 個分會 - 「世界華人工商婦女企管協會」台北第一分會，廣納更多的優秀婦女菁英加入，以壯大本會。
- 2007 年 10 月黃淑慧女士接任第六屆總會長，並以「學習成長、經驗交流、資源共享、拔擢領袖、



國民外交」為會務發展目標，凝聚全球華商姐妹情誼。

- 2008 年黃淑慧總會長創辦「華冠學苑」研習營，強化工商婦女菁英之經濟競爭力，並營造世華為學習型社團組織。
- 2009 年 6 月成立本會第 37 個分會 - 「世界華人工商婦女企管協會」台北第二分會凝聚工商婦女的力量，為姐妹開啟新的人生視野。
- 2010 年 10 月施郭鳳珠女士接任第七屆總會長，為擴展會務組織，積極輔導新分會成立，建構更為穩固的發展基礎。
- 2011 年 2 月北德州分會之復會；2 月成立「亞利桑那分會」第 38 個分會；5 月成立「紐西蘭分會」第 39 個分會；9 月成立「大台中分會」第 40 個分會。
- 2012 年 4 月成立「北加州分會」第 41 個分會；8 月成立「拉斯維加斯分會」第 42 個分會；12 月成立「大台南分會」第 43 個分會。
- 2013 年 2 月成立「大高雄分會」第 44 個分會；3 月成立「芝加哥分會」第 45 個分會；3 月成立「溫哥華分會」第 46 個分會；4 月成立「新加坡分會」第 47 個分會；10 月成立「模里西斯分會」第 48 個分會。
- 2013 年 10 月陳上春女士接任第八屆總會長，以『凝聚、學習、成長、互惠、分享、共榮』為核心價值，擴大世華版圖。
- 2015 年 7 月成立「大桃園分會」第 49 個分會；11 月「阿根廷分會」復會；12 月成立「新北市分會」第 50 個分會。
- 2016 年 4 月成立「華星分會」第 51 個分會；8 月成立「華鳳分會」第 52 個分會；10 月成立「越南分會」第 53 個分會；12 月成立「新竹分會」第 54 個分會。
- 2016 年 10 月黎淑瑛女士接任第九屆總會長，『謙卑學習、感恩奉獻、經貿交流、宏觀視野』為核心價值，進入主流社會提升國際地位。
- 2016 年 12 月成立「大紐約分會」第 55 個分會；「巴爾的摩分會」第 56 個分會。
- 2017 年 3 月成立「新山分會」第 57 個分會；「吉隆坡分會」第 58 個分會；4 月成立「蒙特婁分會」第 59 個分會；「紐澤西分會」復會。8 月成立「亞特蘭大分會」第 60 個分會；9 月成立「日本關西分會」第 61 個分會。
- 2018 年 1 月成立「基隆市分會」第 62 個分會；4 月成立「金邊分會」第 63 個分會；5 月成立「檳城分會」第 64 個分會；6 月成立「維也納分會」第 65 個分會。
- 2018 年 10 月劉琍綺女士接任第十屆總會長，發揚「心懷世界、掌握脈動、建立網絡、發展經貿」宗旨精神，戮力經營世華達「真、善、美」境界。



GFCBW's Background And History

Our federation was formally founded in 1994, of which organization spanned three main oceans and six major continents. All the members in the federation were elites of Chinese businesswomen. The organization had established chapters ever since, of which background and history are listed as follows:

- June 19, 1994, Ms Wen-Chi Chou, founder of GFCBW (Chairperson of former Ming Blossom Perfume Co.) established "The Global Chinese Federation of Business Women" in San Francisco, in hopes of uniting the wisdom of global businesswomen, facilitating the exchange of international information, promoting development of business and economy, and assisting our government to promote citizen diplomacy.
- October 2, 1996, Mrs Jui-Chin Tu Ko assumed the position as 2nd Chairperson.
- November 19, 1997, Mrs Ko Tu Jui Chin renamed the organization as "Global Federation of Chinese Business Women" and filed the application to the Ministry of the Interior of Taiwan for official registration, the federation became the first Taiwan-based global association for businesswomen, with the mission: "envisioning the world" embracing the trend; establishing networks; and developing economy and trade."
- April 1998, Mrs Tu Ko Jui Chin assumed the first Chairperson (third term) of the renamed organization and invited Wen-Hui Tseng, the wife of President Teng-Hui Lee, as Honorary Chairperson. Meanwhile, founder of GFCBW, Mrs Wen-Chi Chou was granted the position as Permanent Honorary Chairperson.
- November 1998, the name and emblem of this federation have formally been registered and approved by the Bureau of Central Standard, Ministry of Economics of Taiwan. In the same year, it was registered in Washington D.C., U.S.A., a procedure that officially stipulated the rights and obligations for the members' using of the name and emblem of this organization.
- 1999, Houston Mayor Dr. Lee P. Brown set May 1st as "the Global Chinese Federation of Business Women Day" and granted an honorary certificate to this federation.
- October 20, 2000, Mrs Ko Tu Jui Chin funded The Chinese Business Women Republic of China and was brought into this Federation as group member.
- February 2001, the scope of GFCBW spanned three main oceans and six major continents in the world and the organization was applied to Ministry of the Interior of Taiwan for official registration as an international association. Mrs Ko Tu Jui Chin continued to renew her term of office as the Chairperson of GFCBW and invited Mrs Cecilia Y. Koo as Honorary Consultant.
- October 2001, Chairperson Ko Tu Jui Chin established "Hua Kuang Award for World Top 10 Outstanding Chinese Women Entrepreneurs," which elected 10 prominent women as winners of the award once in three years.
- 2003, Interior Minister of South Africa-Prince Mangosuthu G. Buthelezi paid a visit to Taiwan and made a speech hosted by this Federation, a move aiming to enhance interaction between both nations and promote Transit without Visa for our citizens who travel to South Africa.
- October 2004, Mrs Liao-Yu Lin assumed as the position as the 5th Chairperson. At the same year, the position "Chairperson" was renamed as "Chief President" in line with the practice of international communities.
- September 2007, Vice President Shu-Huei Huang helped to open the 36th chapter. Taipei City Chapter of Global Federation of Chinese Business Women, in order to recruit more excellent businesswomen.



- October 2007, Mrs Shu-Huei Huang assumed the position as the sixth Chief President and set the goals of federation
- development as learning and growing, experience exchanging, resources sharing, leader cultivating, and citizen diplomacy promoting, so as to strengthen the bond of relationship of our global businesswomen.
- 2008, Chief President Shu-Huei Huang founded “Hua Kuang Training Camp”, aiming to sharpen economic
- competitiveness of our top businesswomen and transform GFCBW as a learning type of organization.
- June 2009, our 37th chapter, Taipei Chapter 2 of Global Federation of Chinese Business Women was founded, with a goal to rally businesswomen’s power and to broaden their horizon.
- October 2010, Mrs Feng Chu Shin Kuo has taken up the 7th chairwoman. In order to expand the organization, Mrs Feng Chu Shih Kuo helped set up new branches actively and established the firmer base of development.
- February 2011, the North Texas Chapter restored.
- 2011, the 38th Arizona Chapter, the 39th New Zealand Chapter, and the 40th Taichung Chapter established.
- 2012, the 41th Northern California Chapter, the 42th Las Vegas Chapter, the 43th Tainan Chapter, the 44th Kaohsiung Chapter established.
- 2013 the 45th Chicago Chapter, the 46th Vancouver Chapter, the 47th Singapore Chapter, the 48th Mauritius Chapter established.
- October 2013, Mrs Teresa Chen took up the 8th Chairwoman, who aims to internationalize the Global Federation of Chinese Business Women based on the core values of “gathering, learning, growing up, reciprocal, sharing, mutually glorious”.
- 2015, the Taoyuan Chapter established.
- November 2015, the Argentina Chapter restored.
- 2015, the 50th New Taipei City Chapter, the 51th Chinese Star Chapter, and the 52th Hua Fong Chapter established.
- October 2016, the 55th New York Chapter, and the 56th Baltimore Chapter of GFCBW established.
- October 2016, Mrs Li Shuying has taken up the 9th Chairwoman, “humility study, gratitude dedication, economic and trade exchanges, macro vision” as the core value, to enter the mainstream society to enhance the international status.
- December 2016, the 55th New York Chapter, and the 56th Baltimore Chapter of GFCBW established.
- March 2017, the 57th Johor Chapter, the 58th Kuala Lumpur Chapter, the 59th Montreal Chapter established. April 2017, the New Jersey Chapter restored. August 2017, the 60th Atlanta Chapter and the 61th Japan Kansai Chapter established.
- January 2018, the 62th Keelung Chapter; the 63th Phnom Penh Chapter; the 64th Penang Chapter; and the 65th Vienna Chapter established.
- October 2018 Mrs. Alice Liu has taken up the 10th Chairwoman. With the mission “envisioning the world; embracing the trend; establishing networks; and developing economy and trade.” to make GFCBW blossom everywhere.




